"The Effective Use of New Information Received under Council
Directive (EU) 2021/514 ('DAC7')"

BACKGROUND

This IOTA webinar will focus on the effective use of new information under Council Directive (EU) 2021/514 ('DAC7') reported by Digital Platform Operators concerning the income derived by sellers (both by individuals and entities) from performing cross-border and non-cross-border commercial activities.

These reporting obligations introduced by the Directive apply, with some exceptions, to operators of online marketplaces (e.g. websites and mobile applications) who provide their interface to sellers making supplies to customers inside the EU. The new reporting obligations on Digital Platform Operators came into effect on 1 January 2023, with the first information being supplied in January 2024. The rules apply to platforms within the European Union as well as those in third countries.

The new data exchange poses new challenges for tax authorities, both in terms of the quality of data provided by DAC7, data analysis, and effective use of data in the compliance management activities of the tax administration.

OBJECTIVES

The objectives of this webinar are to share experiences in obtaining data from Digital Platform Operators, managing and exchanging the data and using the data to identify non-compliance. The event will also facilitate the exchange of experiences (if any) in dealing with non-compliant Digital Platform Operators. While the focus is on EU Member State tax administrations, we are also looking to hear about the experiences of IOTA member tax administrations outside the EU that have legislation enforcing the provision of equivalent information to DAC7.

More specifically, this digital workshop will focus on:

- How the data obtained from Digital Platform Operators is used by Tax Administrations to identify non-compliance by sellers on digital platforms;
- Approaches to the supply and management of information from Digital Platform Operators;
- Possible approaches to tackle non-compliance by Digital Platform Operators and suppliers outside the jurisdiction;
- The application of equivalence and exchanges of relevant information between EU Member States and non-EU countries;
- Sharing of lessons learned.



EXPECTED OUTCOMES

The expected outcomes of this digital workshop are:

- A better understanding how data from Digital Platform Operators can be used to identify non-compliance;
- Improved and shared understanding of issues affecting the exchange and management of data supplied under DAC7;
- Understanding potential approaches to non-compliance, especially by Digital Platform Operators and suppliers outside the jurisdiction;
- The sharing of lessons learned.

METHODOLOGIES

This Webinar will be a practical event, using selected presentations to the processes, methods, tools and good practices applied by the participating IOTA member tax administrations.

The event will be delivered through a combination of **presentations and Q & A** The **presentations** will cover approaches by administrations to obtaining, exchanging and using data from Digital Platform Operators and touch on how administrations are identifying and dealing with instances of non-compliance. The attendees will have the opportunity to raise questions and explore the topic further during the **Q&A sessions**.

There is **no limit** to the number of participants who can attend the IOTA Webinar.
