## Invitation to IOTA Forum on Combating VAT Fraud

Dear Colleagues,

The Intra-European Organisation of Tax Administrations (IOTA) organises the meeting of the IOTA Forum on Combating VAT Fraud which is hosted by the Indirect Taxation Authority of Bosnia and Herzegovina on 11-12 June 2025 in a hybrid format allowing participants to join the sessions either in person in Sarajevo, Bosnia and Herzegovina, or virtually.

The main theme for the 2025 Forum is 'VAT fraud cases: early detection and prevention'.

The purpose of this year's Forum will be to identify new VAT fraud trends (in goods and services/intangibles) as well as to exchange knowledge and expertise on real VAT fraud cases where early detection tools/strategies (e.g. use of new data from e-invoicing, online platforms, payment data) played a decisive role to prevent fraud and safeguard revenue.

International partner organisations (European Commission's DG TAXUD, OECD) as well as international enforcement agencies (EUROPOL, EPPO and OLAF) will contribute to the Forum discussion by sharing their experience on some of the Forum's agenda topics.

We are pleased to invite **one delegate** from each IOTA member tax administration to participate in the Forum in person.

Due to the overall participation limit, once all registrations have been collected, the IOTA Secretariat will confirm the participation of the additional delegate(s) on a first-come, first-served basis. The costs associated with the participation of additional delegate(s) must be covered by the sending administration.

Furthermore, there is **no limit** to the number of participants who wish to attend the sessions of the IOTA Forum online.





Each participating tax administration is required to complete and submit **one Country Profile before 9 May 2025**, briefly describing their experience and their country's situation regarding the Forum's specific topics. Additionally, delegates are asked to identify and list any specific question, problem or solution they would like to be addressed during the Forum's meeting. **More details about how to access the online Country Profile** can be found in the <u>Background Note</u>.

Registration of the delegates from your administration who will be attending the Forum either in person or virtually will be possible through the <u>online registration form by 9 May 2025</u>. Further details about the registration process are provided in the Practical Information document. Please be aware that, in the event, we receive your registration after the deadline, the Organisation will not be able to guarantee accommodation or other items of a logistical nature. Nevertheless, it is planned that this event will be recorded and made available for watching "on-demand" through the dedicated event's webpage on the IOTA web portal.

Delegates attending this event will be experts specialising in the VAT fraud issues within their tax administrations, including tax auditors, investigators and legal experts.
