## BACKGROUND

Tax administrations can collect and utilise a wide variety of HR data from internal and external sources. With advancements in cutting-edge technologies, there is a growing potential for organisations to apply advanced HRM analytical tools and techniques in a more systematic and scientific way.

This event will focus on advanced HR data analytics, predictive tools and other techniques for better decision-making. Tax administrations will present their proactive data-driven approaches to prepare for meeting key emerging challenges in a quickly changing environment. The Webinar will also present examples from several member tax administrations on how they use HR data in their decision-making.

## OBJECTIVES

The main objective of this event is to share country examples of advanced HR data analytics, predictive tools and other techniques for better decision-making. More specifically, the Webinar will:

- Share practical examples, lessons learned and plans for the future.
