The first meeting of the Intra-European Organisation of Tax Administrations' Forum on Tax and Customs Data Science will take place from 4-5 June 2025. The meeting will be held digitally, via Microsoft Teams.

The main theme for the 2025 Forum is ‘*Data and AI – from Governance to Guided Analytics*’.

The purpose of this year's Forum will be to:

- Finalise the mandate for the Forum going forward and set out the working practices and methodologies for the Forum going forward
- Consider good practices in Data Governance and Management
- Share experiences in the use of AI in analytics
