


VAT Fraud Ecossystem: The impact by major investigations






EPPO's Impact on VAT Fraud in the EU


Active criminal networks on 12/03/2025

MOBY DICK Investigation:

How organized entered in the VAT fraud market







An investigation led by Anti-Mafia District Directorate (DDA) on the tracking of high-level members from Cosa Nostra, responsible for murders and violent crimes.

Investigation

The investigation required significant technical work

- 14 environmental wiretaps
- 72 telephone wiretaps
- 16 active and passive telematic wiretaps
- 2 environmental eavesdroppers
- 15 telecameras










OCG piloting the VAT fraud and Money Laundering
