Dear Colleagues,

The Intra-European Organisation of Tax Administrations (IOTA) is organising the meeting of the **Forum on the Use of Data from the Automatic Exchange of Information (AEOI)**, which will be broadcast live on 26th-27th November 2025 in a digital format via Microsoft Teams.

The overall purpose of the Forum is to support the development of effective ways to access and use the Common Reporting Standard (CRS) data. This year's Forum meeting will focus on the following key topics:

- CRS 2.0: Amendments to the Common Reporting Standard. Practical implementation considerations and potential feedback from public consultation,
- CARF: Data collection and reporting requirements from entities and individuals, due diligence procedures to identify Crypto-Asset Users and Controlling Persons
- Methods/Procedures for the use of CRS data to identify non-compliance of FIs/Related audits conducted in this field.
- Methods/Procedures for the use of CRS data to identify non-compliance of domestic taxpayers,
- Methodology IT tools, and CRS data analytics used by tax administrations
