Invitation to the IOTA Digital Workshop “Using AI Solutions to Detect Tax Evasion”

Dear Colleagues,

The Intra-European Organisation of Tax Administrations (IOTA) is organising a **digital workshop** on “Using AI Solutions to Detect Tax Evasion”, which will be **broadcast live** via Microsoft Teams on 3-4 December 2025.

This IOTA Workshop aims to share **practical examples** of how AI solutions can be applied for the detection of tax evasion.

It will also explore current **initiatives**, **projects**, and **tools** supporting the **implementation of AI in tax administrations** for detecting tax evasion, examining the role of external experts, and discussing the main challenges and opportunities associated with adopting these technologies.

The workshop will focus on:

- Identifying **best practices** adopted by IOTA tax administrations in **implementing AI solutions to detect tax evasion**;
- Examining the **challenges** and **benefits** of using AI solutions in tax investigation;
- **Sharing lessons learned** from the implementation of AI initiatives.

Delegates attending this event will be officials from IOTA member tax administrations, such as data scientists, analysts, and experts specialising in the development of analytical models and the use of artificial intelligence to detect tax evasion, as well as officials interested in learning from the experiences of other administrations in this area.

The workshop will be conducted through a mix of presentations, Q&A sessions, and group discussions.

The group discussion sessions – reserved to those participants who wish to engage actively in the discussion – will provide participants the opportunity to share their approaches on the following topics:

- **Day 1:** How to plan, implement and evaluate AI solutions for detecting tax evasion; and
- **Day 2:** Challenges and future developments in using AI solutions to detect tax evasion.

There is no limit to the number of participants from each tax administration. However, registration is mandatory and must be completed by **1 December 2025** using the [IOTA e-registration form](#) available on the IOTA web portal.

Delegates who wish to actively participate in the group discussion session by sharing experiences, views, or insights must indicate this in the registration form.

A Microsoft Teams access link will be sent to all registered participants via email by the IOTA Secretariat the day before the event. However, the event will be recorded and made available for on-demand viewing on the IOTA website (accessible only to registered users).


